Roles & Responsibilities of the Facilities Manager

School facility officials are multi-faceted leaders whose roles and responsibilities are both strategic and operational. A school facility official will partner and coordinate strategic planning with the business manager, district administrator, board, and community to support the vision and mission of the district. Though the role & responsibilities on each facilities leader may vary in each district, it's vital to ensure a staff member in your district is executing the following rules & responsibilities complied by WASBO's School Facilities Committee:

Role of the Facility Manager

The typical role of a facility manager varies between each district. Facilities managers are responsible for the maintenance and upkeep of the district's buildings and grounds, ensuring that they meet legal requirements as well as health and safety standards.

Facility managers operate across different functions, working on both a strategic and operational level.

Facility management professionals are tasked with providing, maintaining and developing a number of different services such as:

- Property strategy
- Space management
- Communications infrastructure
- Building and grounds maintenance
- Testing and inspections
- Building administration
- Contract management
- Environment, health, safety
- Safety/Security
- Facilities continuity planning
- Managing renovations and refurbishments
- Transportation
- Human Resources
- Emergency response & preparedness
- Risk Management

Responsibilities of the Facility Manager

Generally speaking, the role of the facility manager is to ensure that the facility is operating as it should on a daily basis by completing daily inspections and conducting proactive and reactive maintenance. A facility manager is responsible for:

- Sourcing and overseeing contracts and service providers for functions such as catering, cleaning, parking, security, and technology
- Advising on measures to improve efficiency and cost-effectiveness of the facility
- Supervising teams of staff across various departments
- Ensuring that basic facilities are well-maintained
- Conducting proactive maintenance
- Responding to emergencies
- Advocating for safe & healthy learning environments
- Developing and managing budgets
- Ensuring that facilities meet compliance standards and government regulations
- Planning for the future by forecasting the facility's upcoming needs and requirements
- Communicating the Facility Plan
- Understanding Building Automation
- Capital projects planning to oversee renovations, refurbishments and building projects
- Helping with classroom relocations
- Establishing preventative maintenance programs
- Advising Administrators and the School Board on aspects of their facilities status
- Energy management
- Safety coordinator
- Staff training
- Leading by fulfilling the district's mission & vision
